Equities market closes on a Positive note... ASI gains 18 Basis Point

The Nigerian Exchange Limited (NGX) closed Positive. The benchmark All Share Index (ASI) appreciated by 0.18% to close at 42,038.60. Market Capitalization increased by 40.42 Billion to close at N21.94 trillion while the Year-to-Date (YtD) returns settled at 4.39%.

What shaped today's market direction?

Today's market direction can be largely attributed to gains recorded in large and mid-cap stocks in Banking, Industrial and Consumer goods sector. Some of today's market gainers include: **GUINNESS (10.00%), CUSTODIAN (9.74%), AIICO (9.73%), WEMABANK (9.46%), TOTAL (9.45%), ETERNA (8.13%), WAPCO (5.47%), ETI (4.09%), TRANSCORP (1.90%), UBA (1.59%), UBA (1.18%), UCAP (1.10%), FIDELITYBK (1.09%), ZENITHBANK (0.80%), ACCESS (0.53%), MANSARD (0.43%) and GTCO (0.35%) amongst others.**

Sectors performance was Broadly Bullish.

Performance across sectors was broadly bullish as 4 out of 5 sectors closed in the green zone. Banking, Industrial, Oil & Gas and Insurance Indices advanced by 1.23%, 0.34%, 2.10% and 1.47% respectively. While Consumer Goods Index declined by 0.05%.

Market activity measured by aggregate volume increased by 102.14% while value increased by 212.85%. Investors traded a total of 1.13 billion units of shares valued at 13.78 billion in 5,458 deals.

Market breadth measured by Advancers/Decliners was Positive as it closed at 1.68x indicating a Bullish mood. At the close of **GUINNESS (10.00%), CUSTODIAN (9.74%), AIICO (9.73%), WEMABANK (9.46%), TOTAL (9.45%), ETERNA (8.13%), WAPCO (5.47%), ETI (4.09%), TRANSCORP (1.90%), UBA (1.59%), UBA (1.18%), UCAP (1.10%), FIDELITYBK (1.09%), ZENITHBANK (0.80%), ACCESS (0.53%), MANSARD (0.43%) and GTCO (0.35%)** were amongst the 32 market gainers **DANGSUGAR (-5.56%), FBNH (-5.15%), GLAXOSMITH (-3.17%), NB (-2.30%), ARDOVA (-2.01%), OANDO (-0.98%), UACN (-0.88%), NAHCO (-0.87%) and HONYFLOUR (-0.28%)** amongst others were the 19 market laggards. 58 stock prices remained unchanged.

Other Financial Institutions emerged as the most active sector. Equities of FBNH, FCMB and GTCO were the most active in the subsector as 86 million units of shares worth N986 Million were traded in 1,824 transactions. FBNH, FCMB and GTCO accounted for 89% of the total volume traded in the subsector.

Banking sector came second ahead of Insurance. Equities of WEMABANK and STERLNBANK were the most active in the subsector as 85 million units of shares worth N574 Million were traded in 1,979 transactions. Trading in the Equities of WEMABANK and STERLNBANK accounted for 43% of the total volume traded in the subsector.

NASD Market

The NASD market closed Positive after today's trading activities as the Unlisted Securities Index (USI) increased by 0.29% to close at 746.86. Consequently, Market Capitalization closed at 617.04 billion. Market activity measured by aggregate volume increased 1,089.54% while value increased by 1,047.52%. Investors traded a total of 1,380,413 units of shares valued at 94.91 million in 25 deals.

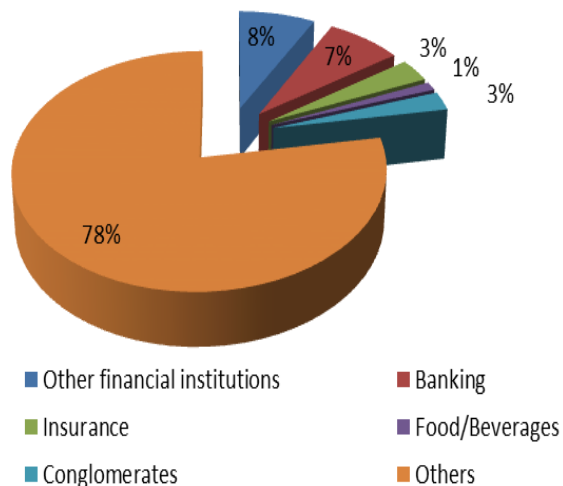
