## NGX All Share Index closes on a Positive note... ASI gains 51 Basis Points

The Nigerian Exchange Limited Bourse closed Positive. The benchmark All Share Index (ASI) appreciated by 0.51% to close at 46,867.95. Market Capitalization increased by 127.49 billion to close at N25.27 trillion while the Year-to-Date (YtD) returns settled at 9.72%.

### What shaped today's market direction?

Today's market direction can be largely attributed to gains recorded in large and mid-cap stocks in Banking, Industrial and Consumer Goods. Some of today's market gainers include, **NAHCO (10.00%), UACN (9.90%), WAPIC (7.50%), FIDELITYBK (5.34%), UCAP (4.96%), ZENITHBANK (4.35%), WAPCO (3.41%), TRANSCORP (3.06%), MAYBAKER (2.33%), ACCESSCORP (2.04%), UBA (1.27%) and MTNN (1.21%) amongst others.**

### Sectors performance was Broadly Bullish

Performance across sectors was broadly bullish as 4 out of 5 sectors closed in the green zone. Banking, Consumer Goods, Industrial and Insurance Indices advanced by 2.83%, 1.02%, 0.22% and 1.38% respectively. While Oil/Gas Index declined by 0.14%.

Market activity measured by aggregate volume increased by 45.76% while value increased by 117.91%. Investors traded a total of 224 million units of shares valued at N3.82 billion in 5,946 deals.

Market breadth measured by Advancers/Decliners was Positive as it closed at 2.46x indicating a Bullish mood. At the close of trading, **NAHCO (10.00%), UACN (9.90%), WAPIC (7.50%), FIDELITYBK (5.34%), UCAP (4.96%), ZENITHBANK (4.35%), WAPCO (3.41%), TRANSCORP (3.06%), MAYBAKER (2.33%), ACCESSCORP (2.04%), UBA (1.27%) and MTNN (1.21%)** were amongst the 32 market gainers **ACADEMY (-9.60%), PRESTIGE (-4.44%), UNITYBANK (-2.13%), VITAFOAM (-2.02%), FCMB (-1.16%), OANDO (-1.04%), HONYFLOUR (-0.58%), NASCON (-0.43%) and GTCO (-0.22%) amongst others** were the 13 market laggards. 64 stock prices remained unchanged.

Banking emerged as the most active sector. Equities of ZENITHBANK, STERLNBANK and FIDELITYBK were the most active in the subsector as 79.96 million units of shares worth N892.93 million were traded in 2,450 transactions. Trading in the Equities of ZENITHBANK, STERLNBANK and FIDELITYBK accounted for 86% of the total volume traded in the subsector.

Other Financial Institutions sector came second ahead of Insurance. Equities of GTCO and ACCESSCORP were the most active in the subsector as 71.64 million units of shares worth N1.28 billion were traded in 2,802 transactions. Trading in the Equities of GTCO and ACCESSCORP accounted for 78% of the total volume traded in the subsector.

### NASD Market

The NASD market closed Positive after today's trading activities as the Unlisted Securities Index (USI) increased by 1.36% to close at 748.90. Consequently, Market Capitalization closed at 984.72 billion. Market activity measured by aggregate volume increased by 150.04% and value decreased by 46.87%. Investors traded a total of 2.53 million units of shares valued at N29.17 million in 37 deals.

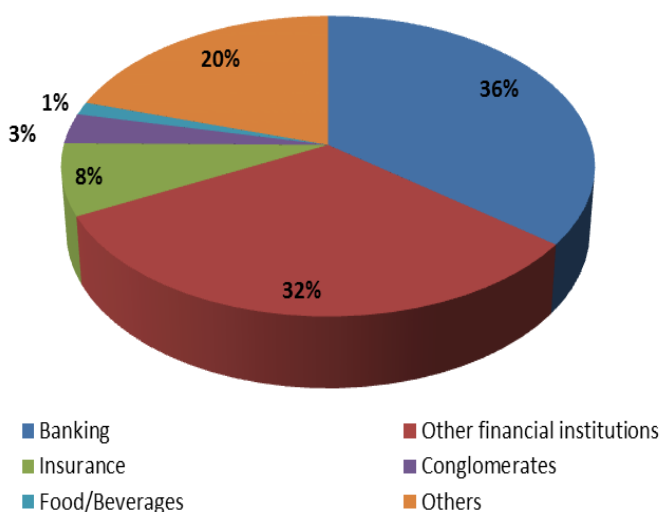
