

Daily Market Report



Friday, Aug 29, 2025

The ASI depreciated by 51bps week on weekdown by 19bps today.

The local bourse (NGX) depreciated by **51bps** week on week marking the third bearish weekly close, in today's market ASI depreciated by **19bps**, driven by price depreciation and profit taking in all sectoral tickers. As a result, the benchmark All Share Index (ASI) closed negatively to settle at **140,284.90pts**.

Market Capitalization closed negatively at **N88.76trillion**, as investors lost **N172.31billion**, and Year-to-date (YtD) gain decreased to **36.30%**.

What shaped today's market direction

The losses in today's market can majorly be attributed to price depreciation and profit taking in **GTCO (-0.05%)**, **ZENITHBANK (-4.35%)**, **FIRSTHOLDCO (-0.15%)** and **ACCESSCORP (-1.85%)** with offsetting gains in **FCMB (3.33%)**, **WEMABANK (2.45%)**, **ELLAHLAKES (3.07%)** and **UCAP (1.58%)** which kept the ASI in negative terrain. losses were recorded in large-cap, mid-cap, and small-cap stocks. The market breadth measured by advancers/ decliners was negative, closing at **0.58x**, indicating laggards more than advancers. The top gainers include **LEARNAFRCA (9.86%)**, **UNIIONDICON (8.04%)**, **PRESTIGE (6.75%)**, **ACADEMY (6.11%)** and **OMATEK (6.06%)**

Sectoral performance was negative

Sectoral performance was negative. All our observed indices closed negatively due to price depreciation in all sectoral tickers. As a result, the year-to-date (YTD) gain decreased to **36.30%**.

At the close of today's trade, **JOHNHOLT (-10%)**, **LASACO (-9.64%)**, **GUINEAINS (-7.79%)**, **UNIVINSURE (-6.25%)** and **NSLTECH (-5.56%)** were among the **31** market laggards as **126** stocks traded today.

Market activity, measured by aggregate volume, decreased by **50.83%**, with aggregate value depreciating by **63.24%**. Investors traded a total of **435.12mn** units of shares valued at **N10.38bn** in **25,448** deals.

The most active stocks by volume were **VFDGROUP**, which traded **49.29mn** units, followed by **NSLTECH** with **33.17mn** units, **ACCESSCORP** with **26.85mn** units, **GTCO** with **21.33mn**, and **FIRSTHOLDCO** with **19.93mn** units.

The most active stocks by value were **GTCO**, which traded **N1.96bn**, followed by **ZENITHBANK** with **N1.17bn**, **WAPCO** with **N932.84mn**, **ACCESSCORP** with **N716.97mn**, and **FIRSTHOLDCO** with **N646.66mn**.
