October starts the month on a bullish note.....as the ASI appreciated by 19bps

The month of October opened on bullish note as the local bourse (NGX) appreciated by **19bps** today, driven by price appreciation and increase buying interest in all sectoral tickers except **NGXINDUSTR**. As a result, the benchmark All Share Index (ASI) closed positively to settle at **142,979.45pts**.

Market Capitalization closed positively at **N90.75trillion**, as investors gained **N170.72billion**, and Year-to-date (Ytd) gain increased to **38.91%**.

What shaped today's market direction

The gains in today's market can majorly be attributed to price appreciation and increased buying interest in **WEMABANK (1.76%)**, **GTCO (2.13%)**, **NB (1.71%)** and **MTNN (0.47%)** with offsetting losses in **UBA (-0.46%)**, **FIRSTHOLDCO (-1.59%)**, **WAPCO (-0.08%)** and **FIDELITYBK (-2.38%)** which kept the ASI in a positive terrain. gains were recorded in large-cap, mid-cap, and small-cap stocks in **NGX30**, **NGXBNK**, **NGXCG**, **NGXINS**, and **NGXOILGAS**. The market breadth measured by advancers/decliners was positive, closing at **1.31x**, indicating more advancers than laggards. The top gainers include **PZ (10.00%)**, **ETERNA (9.94%)**, **CHAMPION (9.82%)**, **TANTALIZER (5.96%)** and **AIICO (5.43%)**.

Sectoral performance was positive

Sectoral performance was positive. All our observed indices closed positively due to increased buying interest in **NGX30**, **NGXBNK**, **NGXCG**, **NGXINS**, and **NGXOILGAS** while **NGXINDUSTR** closed negatively. As a result, the year-to-date (YTD) gain increased to **38.91%**.

At the close of today's trade **RTBRISCOE (-9.89%)**, **THOMASWY (-9.82%)**, **SOVRENINS (-9.33%)**, **INTENEGINS (-7.78%)** and **BERGER (-7.18%)** were among the **26** market laggards as **128** stocks traded today.

Market activity measured by aggregate volume decreased by **36.69%**, with aggregate value depreciating by **1.43%**. Investors traded a total of **785.32mn** units of shares valued at **N29.38bn** in **32,546** deals.

The most active stocks by volume were **UBA**, which traded **152.13mn**, followed by **WEMABANK** with **152.04mn** units, **FIRSTHOLDCO** with **111.79mn** units, **ZENITHBANK** with **47.09mn**, and **STANBIC** with **31.02mn** units.

The most active stocks by value were **UBA**, which traded **N6.54bn**, followed by **FIRSTHOLDCO** with **N3.48bn**, **STANBIC** with **N3.41bn**, **ZENITHBANK** with **N3.26bn**, and **WEMABANK** with **N2.51bn**.
