The market closed on a bullish note.....as the ASI appreciated by 12bps for the day

The local bourse (NGX) increased by **12bps** driven by price appreciation and increased buying interest in **NGX30**, **NGXINDUSTR**, **NGXINS**. As a result, the benchmark All Share Index (ASI) closed positively to settle at **144,995.26**.

Market Capitalization closed positively at **N92.03trillion**, as investors gained **N109.47billion**, and Year-to-date (YtD) gain increased to **40.87%**.

What shaped today's market direction

The gains in today's market can majorly be attributed to price appreciation and increase buying interest in DANGCEM (0.93%), WAPCO (1.98%), MTNN (2.27%) and UBA (0.71%) offsetting losses in ARADEL (-1.59%), ELLAHLAKES (-0.74%), GTCO (-4.04%) and ZENITHBANK (-0.58%) which kept the ASI in a positive terrain. Gains were recorded in large-cap, mid-cap, and small-cap stocks in NGX30, NGXINDUSTR, NGXINS. The market breadth measured by advancers/ decliners was positive, closing at 1.18x, indicating more advancers than laggards The top gainers include CORNERST (9.92%), CONHALLPLC (9.52%), CHAMS (9.22%), VFDGROUP (9.17%) and INTENEGINS (8.82%).

Sectoral performance was mixed

Sectoral performance was mixed. Some of our observed indices closed positively due to increased buying interest in **NGX30**, **NGXINDUSTR**, **NGXINS** while **NGXBNK**, **NGXCG**, **NGXOILGAS** closed negatively. As a result, the year-to-date (YTD) gain increased to **40.87%**.

At the close of today's trade LIVINGTRUST (-10%), AUSTINLAZ (-9.74%), LIVESTOCK (-7.5%), TANTALIZER (-6.45%) and FTNCOCOA (-5.81%) were among the 33 market laggards as 126 stocks traded today.

Market activity measured by aggregate volume decreased by **2.43%**, while aggregate value depreciating by **67.05%**. Investors traded a total of **507.28mn** units of shares valued at **N24.28bn** in **30,531** deals.

The most active stocks by volume were ACCESSCORP, which traded 45.86mn, followed by ELLAHLAKES with 39.48mn units, CHAMS with 30.82mn units, SOVRENINS with 27.78mn, and ARADEL with 22.57mn units.

The most active stocks by value were **ARADEL**, which traded **N13.15bn**, followed by **DANGCEM** with **N1.57bn**, **ACCESSCORP** with **N1.19bn**, **WAPCO** with **N644.65mn**, and **ELLAHLAKES** with **N594.31mn**.
