ASI at a new all-time high closed above 145,000.....market up by 50bps today

The ASI is at a new all-time high in today's market, the local bourse (NGX) appreciated by **50bps** driven by price appreciation and increased buying interest in all sectoral tickers except **NGXINDUSTR**, **NGXINS**. As a result, the benchmark All Share Index (ASI) closed positively to settle at **145,719.09**.

Market Capitalization closed positively at **N92.49trillion**, as investors gained **N459.42billion**, and Year-to-date (YtD) gain increased to **41.58%**.

What shaped today's market direction

The gains in today's market can majorly be attributed to price appreciation and increase buying interest in **ARADEL (1.58%)**, **ZENITHBANK (0.58%)**, **MTNN (4.64%)** and **ACCESSCORP (0.77%)** offsetting losses in **WAPCO (-0.19%)**, **UBA (-0.12%)**, **CONHALLPLC (-2.52%)** and **ELLAHLAKES (-5.44%)** which kept the ASI in a positive terrain. Gains were recorded in large-cap, mid-cap, and small-cap stocks in **NGX30**, **NGXBNK**, **NGXCG**, **NGXOILGAS**. The market breadth measured by advancers/ decliners was negative closing at **0.85x**, indicating more laggards than advancers. The top gainers include **FTNCOCOA (8.89%)**, **LIVESTOCK (7.43%)**, **ETERNA (6.96%)**, **PRESTIGE (4.94%)** and **FIDELITYBK (4.74%)**.

Sectoral performance was positive

Sectoral performance was positive. All our observed indices closed positively due to increased buying interest in **NGX30**, **NGXBNK**, **NGXCG**, **NGXOILGAS** except **NGXINDUSTR**, **NGXINS** which closed negatively. As a result, the year-to-date (YTD) gain increased to **41.58%**.

At the close of today's trade **IMG (-9.97%)**, **LIVINGTRUST (-9.93%)**, **SUNUASSUR (-9.48%)**, **JAIZBANK (-7.53%)** and **CHAMS (-6.28%)** were among the **34** market laggards as **130** stocks traded today.

Market activity measured by aggregate volume increased by **3.62%**, while aggregate value appreciating by **44.02%**. Investors traded a total of **525.65mn** units of shares valued at **N13.59bn** in **25,433** deals.

The most active stocks by volume were **CONHALLPLC**, which traded **83.54mn**, followed by **FIRSTHOLDCO** with **36.53mn** units, **JAIZBANK** with **28.72mn** units, **CHAMS** with **24.46mn**, and **ELLAHLAKES** with **21.36mn** units.

The most active stocks by value were **GTCO**, which traded **N1.79bn**, followed by **WAPCO** with **N1.39bn**, **ARADEL** with **N1.3bn**, **ZENITHBANK** with **N1.28bn**, and **FIRSTHOLDCO** with **N1.13bn**.
