The All-Share Index inched up in today's market....up by 2bps for the day

The local bourse (NGX) closed the day on a bullish note as ASI appreciated by **2bps** driven by price appreciation and increase buying interest in **NGX30, NGXINDUSTR, NGXOILGAS**. As a result, the benchmark All Share Index (ASI) closed positively to settle at **147,741.77pts**.

Market Capitalization closed positively at **N93.77trillion**, as investors gained **N19.55billion**, and Year-to-date (YtD) gain increased to **43.54%**.

What shaped today's market direction

The gains in today's market can majorly be attributed to price appreciation and increase buying interest in **ZENITHBANK (0.15%), FIDELITYBK (0.25%), STANBIC (1.61%)** and **NESTLE (1.23%)** offsetting losses in **NB (-1.67%), GTCO (-0.64%), ACCESSCORP (-0.58%)** and **DANGSUGAR (-0.5%)** which kept the ASI in a positive terrain. Gains were recorded in large-cap, mid-cap, and small-cap stocks in **NGX30, NGXINDUSTR, NGXOILGAS**. The market breadth measured by advancers/ decliners was positive closing at **1.17x**, indicating more advancers than laggards. The top gainers include **SFSREIT (9.88%), ROYALEX (7.37%), INTENEGINS (6.05%), JBERGER (5.51%)** and **OMATEK (4.9%)**.

Sectoral performance was mixed

Sectoral performance was mixed. Some of our observed indices closed positively due to increase buying interest in **NGX30, NGXINDUSTR, NGXOILGAS** while **NGXBNK, NGXCG, NGXINS** closed negatively. As a result, the year-to-date (YTD) gain increased to **43.54%**.

At the close of today's trade **TRIPPLEG (-9.91%), IMG (-9.87%), UACN (-6.46%), ELLAHLAKES (-4.66%)** and **JAPAUFGOLD (-4.51%)** were among the **28** market laggards as **127** stocks traded today.

Market activity, measured by aggregate volume, decreased by **21.43%**, with aggregate value depreciating by **28.66%**. Investors traded a total of **388.93mn** units of shares valued at **N12.35bn** in **22,871** deals.

The most active stocks by volume were **FIDELITYBK**, which traded **46.87mn** units, followed by **CHAMS** with **24.76mn** units, **ZENITHBANK** with **20.84mn** units, **ACCESSCORP** with **19.21mn**, and **FIRSTHOLDCO** with **16.59mn** units.

The most active stocks by value were **ZENITHBANK**, which traded **1.42bn** units, followed by **NB** with **1.27bn** units, **FIDELITYBK** with **942.31mn** units, **GTCO** with **869.05mn**, and **STANBIC** with **723.52mn** units.
