The All-Share Index closed on a bullish note...appreciating by 41bps for the day

In today's market, the local bourse (NGX) advanced by **41bps** driven by price appreciation and increased buying interest in all sectoral tickers except **NGXINS**. As a result, the benchmark All Share Index (ASI) closed positively to settle at **148,355.04**.

Market Capitalization closed positively at **N94.16trillion**, as investors gained **N388.96billion**, and Year-to-date (YtD) gain increased to **44.14%**.

What shaped today's market direction

The gains in today's market can majorly be attributed to price appreciation and increase buying interest in **GTCO (0.11%)**, **ARADEL (0.48%)**, **NESTLE (1.16%)** and **MTNN (0.06%)** offsetting losses in **ZENITHBANK (-0.07%)**, **UBA (-0.94%)**, **FIDELITYBK (-0.25%)** and **DANGSUGAR (-2.51%)** which kept the ASI in a positive terrain. Gains were recorded in large-cap, mid-cap, and small-cap stocks in **NGX30**, **NGXBNK**, **NGXCG**, **NGXINDUSTR**, **NGXOILGAS**. The market breadth measured by advancers/ decliners was positive closing at **1.15x**, indicating more advancers than laggards. The top gainers include **NSLTECH (7.06%)**, **STERLINGNG (6.49%)**, **LIVESTOCK (5.33%)**, **TIP (5.18%)** and **MAYBAKER (4.99%)**.

Sectoral performance was positive

Sectoral performance was positive. All our observed indices closed positively due to increase buying interest in **NGX30**, **NGXBNK**, **NGXCG**, **NGXINDUSTR**, **NGXOILGAS** except **NGXINS** which closed negatively. As a result, the year-to-date (YTD) gain increased to **44.14%**.

At the close of today's trade, **SUNUASSUR (-9.71%)**, **HMCALL (-7.53%)**, **DAARCOMM (-6.36%)**, **SOVRENINS (-6.05%)** and **CUSTODIAN (-4.55%)** were among the **26** market laggards as **128** stocks traded today.

Market activity, measured by aggregate volume, increased by **11.15%**, with aggregate value appreciating **35.95%**. Investors traded a total of **432.31mn** units of shares valued at **N16.80bn** in **23,518** deals.

The most active stocks by volume were **CONHALLPLC**, which traded **40.95mn** units, followed by **ACCESSCORP** with **40.34mn** units, **GTCO** with **27.56mn** units, **ZENITHBANK** with **25.04mn**, and **TANTALIZER** with **22.23mn** units.

The most active stocks by value were **GTCO**, which traded **2.57bn** units, followed by **ARADEL** with **2.52bn** units, **ZENITHBANK** with **1.7bn** units, **NESTLE** with **1.32bn**, and **MTNN** with **1.06bn** units.
