The ASI closed the week on a bullish note by 135bps.....Up by 42bps for the day

The local bourse (NGX) closed the week on a bullish note by **135bps**, in today's market, The local bourse (NGX) advanced by **42bps** driven by price appreciation and increase buying interest in all sectoral tickers except **NGXCG, NGXOILGAS**. As a result, the benchmark All Share Index (ASI) closed positively to settle at **148,977.78pts**.

Market Capitalization closed positively at **N94.56trillion**, as investors gained **N395.27billion**, and Year-to-date (YtD) gain increased to **44.74%**

What shaped today's market direction

The gains in today's market can majorly be attributed to price appreciation and increase buying interest in **DANGCEM (0.03%), MTNN (0.66%), NASCON (1.00%) and VITAFOAM (2.96%)** offsetting losses in **ACCESSCORP (-0.58%), FIDELITYBK (-0.5%), NB (-0.78%) and GTCO (-0.21%)** which kept the ASI in a positive terrain. Gains were recorded in large-cap, mid-cap, and small-cap stocks in **NGX30, NGXBNK, NGXINDUSTR, NGXINS**. The market breadth measured by advancers/decliners was positive closing at **1.69x**, indicating more advancers than laggards. The top gainers include **EUNISELL (10%), UPDC (9.92%), SOVRENINS (9.51%), UNIVINSURE (9.09%)** and **DAARCOMM (8.74%)**.

Sectoral performance was positive

Sectoral performance was positive. All our observed indices closed positively due to increase buying interest in **NGX30, NGXBNK, NGXINDUSTR, NGXINS** except **NGXCG, NGXOILGAS** which closed negatively. As a result, the year-to-date (YTD) gain increased to **44.74%**.

At the close of today's trade, **LIVINGTRUST (-10.00%), INTENEGINS (-8.39%), CONHALLPLC (-6.29%), STERLINGNG (-4.88%)** and **WAPIC (-4.55%)** were among the **23** market laggards as **128** stocks traded today.

Market activity, measured by aggregate volume, increased by **11.22%**, while aggregate value appreciating by **0.79%**. Investors traded a total of **480.83mn** units of shares valued at **N16.66bn** in **22,705** deals.

The most active stocks by volume were **UBA**, which traded **59.17mn** units, followed by **ACCESSCORP** with **50.38mn** units, **FIDELITYBK** with **46.98mn** units, **SOVRENINS** with **34.24mn**, and **TANTALIZER** with **24.55mn** units.

The most active stocks by value were **DANGCEM**, which traded **N2.63bn**, followed by **UBA** with **N2.48bn**, **ACCESSCORP** with **N1.29bn**, **MTNN** with **N1.16bn**, and **FIDELITYBK** with **N944.02mn**.
