## ASI starts the week on a bearish note ..... down by 25bps for the day

The Nigeria All Share Index (ASI) starts the week on a bearish note, in today's market, The local bourse (NGX) decreased by **25bps** driven by price depreciation and profit taking in all sectoral tickers. As a result, the benchmark All Share Index (ASI) closed negatively to settle at **153,739.65pts**.

Market Capitalization closed negatively at **N97.58trillion**, as investors lost **N245.51billion**, and Year-to-date (YtD) gain decreased to **49.37%**.

### What shaped today's market direction

The loss in today's market can majorly be attributed to price depreciation and profit taking in **ARADEL (-9.21%)**, **ACCESSCORP (-3.07%)**, **UACN (-2.26%)** and **FIRSTHOLDCO (-0.16%)** offsetting gains in **UBA (1.12%)**, **OKOMUOIL (3.74%)**, **GUINNESS (1.76%)** and **ASOSAVINGS (3.88%)** which kept the ASI in negative terrain. Losses were recorded in large-cap, mid-cap, and small-cap stocks in **NGX30**, **NGXBNK**, **NGXCG**, **NGXINS**, **NGXOILGAS**. The market breadth measured by advancers/ decliners was negative closing at **0.50x**, indicating more laggards than advancers The top gainers include **UNIONDICON (9.93%)**, **OMATEK (9.92%)**, **NAHCO (7.62%)**, **INTBREW (6.35%)** and **CHAMPION (6.33%)**.

### Sectoral performance was negative

Sectoral performance was negative. All our observed indices closed negatively due to price depreciation and profit taken in **NGX30**, **NGXBNK**, **NGXCG**, **NGXINS**, **NGXOILGAS** except **NGXINDUSTR** which closed flat. As a result, the year-to-date (YTD) gain decreased to **49.37%**.

At the close of today's trade **HONYFLOUR (-10%)**, **NNFM (-9.98%)**, **ARADEL (-9.21%)**, **JAPAUFGOLD (-7.95%)** and **IKEJAHOTEL (-7.71%)** were among the **38** market laggards as **130** stocks traded today.

Market activity measured by aggregate volume increased by **19.38%**, with aggregate value appreciating by **8.46%**. Investors traded a total of **627.49mn** units of shares valued at **N24.99bn** in **36,282** deals.

The most active stocks by volume were **UBA**, which traded **136.83mn**, followed by **ASOSAVINGS** with **108.94mn** units, **ACCESSCORP** with **68.15mn** units, **GTCO** with **49.82mn**, and **ZENITHBANK** with **31.80mn** units.

The most active stocks by value were **UBA**, which traded **N5.54bn**, followed by **GTCO** with **N4.54bn**, **OKOMUOIL** with **N2.28bn**, **ZENITHBANK** with **N2bn**, and **ARADEL** with **N1.88bn**.
