

# Daily Market Report

## ASI close the day on a bearish note ..... down by 119bps for the day

The local bourse (NGX) closed the day on a bearish note as ASI depreciated by **119bps** driven by price depreciation and profit taking in all sectoral tickers except **NGXOILGAS**. As a result, the benchmark All Share Index (ASI) closed negatively to settle at **150,812.02pts**.

Market Capitalization closed negatively at **N95.81trillion**, as investors lost **N1.15trillion**, and Year-to-date (YtD) gain decreased to **46.52%**.

### What shaped today's market direction

The loss in today's market can majorly be attributed to price depreciation and profit taking in **ZENITHBANK (-1.22%)**, **MTNN (-5.94%)**, **STERLINGNG (-1.25%)** and **UACN (-7.69%)** offsetting gains in **GTCO (0.94%)**, **ARADEL (1.06%)**, **UBA (2.41%)** and **PZ (1.28%)** which kept the ASI in a negative terrain. Losses were recorded in large-cap, mid-cap, and small-cap stocks in **NGX30**, **NGXBNK**, **NGXCG**, **NGXINDUSTR**, **NGXINS**. The market breadth measured by advancers/ decliners was negative closing at **0.34x**, indicating more laggards than advancers. The top gainers include **NCR (10%)**, **LEGENDINT (9.16%)**, **CORNERST (8.8%)**, **UPDC (8.3%)** and **LINKASSURE (8.11%)**.

### Sectoral performance was negative

Sectoral performance was negative. All our observed indices closed negatively due to price depreciation and profit taken in **NGX30**, **NGXBNK**, **NGXCG**, **NGXINDUSTR**, **NGXINS** except **NGXOILGAS** which closed positively. As a result, the year-to-date (YTD) gain decreased to **46.52%**.

At the close of today's trade **TRANSCORP (-10%)**, **CILEASING (-10%)**, **SKYAVN (-9.99%)**, **BETAGLAS (-9.99%)** and **RTBRISCOE (-9.92%)** were among the 46 market laggards as 128 stocks traded today.

Market activity measured by aggregate volume decreased by **24.37%**, with aggregate value depreciating by **21.58%**. Investors traded a total of **517.23mn** units of shares valued at **N15.97bn** in **27,167** deals.

The most active stocks by volume were **STERLINGNG**, which traded **81.65mn**, followed by **ZENITHBANK** with **53.66mn** units, **FCMB** with **40.40mn** units, **ACCESSCORP** with **39.42mn**, and **GTCO** with **28.51mn** units.

The most active stocks by value were **ZENITHBANK**, which traded **N3.28bn**, followed by **GTCO** with **N2.45bn**, **ARADEL** with **N1.29bn**, **MTNN** with **N1.07bn**, and **ACCESSCORP** with **N915.46mn**.
