

# Daily Market Report

## ASI close the day on a bearish note ..... down by 36bps for the day

The local bourse (NGX) closed the day on a bearish note as ASI declined by **36bps**, driven by price depreciation and profit taking in all sectoral tickers except **NGXINDUSTR**. As a result, the benchmark All Share Index (ASI) closed negatively to settle at **150,026.55pts**.

Market Capitalization closed negatively at **N95.31trillion**, as investors lost **N347.73billion**, and Year-to-date (YtD) gain decreased to **45.76%**.

### What shaped today's market direction

The loss in today's market can majorly be attributed to price depreciation and profit taking in **ZENITHBANK (-1.48%)**, **GUINNESS (-3.41%)**, **GTCO (-0.52%)** and **ACCESSCORP (-2.17%)** offsetting gains in **FCMB (8%)**, **UBA (1.36%)**, **CONHALLPLC (1.24%)** and **WAPCO (1.54%)** which kept the ASI in a negative terrain. Losses were recorded in large-cap, mid-cap, and small-cap stocks in **NGX30**, **NGXBNK**, **NGXCG**, **NGXINS**, **NGXOILGAS**. The market breadth measured by advancers/ decliners was negative closing at **0.38x**, indicating more laggards than advancers. The top gainers include **UPDC (9.83%)**, **FCMB (8%)**, **OMATEK (7.44%)**, **AIICO (5.35%)** and **MANSARD (5.26%)**.

### Sectoral performance was negative

Sectoral performance was negative. All our observed indices closed negatively due to price depreciation and profit taken in **NGX30**, **NGXBNK**, **NGXCG**, **NGXINS**, **NGXOILGAS** except **NGXINDUSTR** which closed positively. As a result, the year-to-date (YTD) gain decreased to **45.76%**.

At the close of today's trade **LEGENDINT (-9.93%)**, **CHAMPION (-9.72%)**, **TANTALIZER (-8.12%)**, **SOVRENINS (-7.51%)** and **LINKASSURE (-7.5%)** were among the **39** market laggards as **129** stocks traded today.

Market activity measured by aggregate volume decreased by **1.25%**, with aggregate value depreciating by **33.98%**. Investors traded a total of **619.62mn** units of shares valued at **N16.50bn** in **24,731** deals.

The most active stocks by volume were **FCMB**, which traded **149.99mn**, followed by **CONHALLPLC** with **79.09mn** units, **ZENITHBANK** with **41.88mn** units, **STERLINGNG** with **38.50mn**, and **ACCESSCORP** with **32.32mn** units.

The most active stocks by value were **ZENITHBANK**, which traded **N2.51bn**, followed by **GUINNESS** with **N1.6bn**, **FCMB** with **N1.59bn**, **DANGCEM** with **N1.49bn**, and **GTCO** with **N1.08bn**.
