ASI starts the week on a bearish note depreciating by 46bps for the day

The Nigeria All Share Index (ASI) starts the week on a bearish note. In today's market, the local bourse (NGX) closed the day on a bearish note as ASI declined by **46bps** driven by price depreciation and profit taking in all sectoral tickers except **NGXOILGAS** which closed flat. As a result, the benchmark All Share Index (ASI) closed negatively to settle at **148,832.19pts**.

Market Capitalization closed negatively at **N94.55trillion**, as investors lost **N440.04billion**, and Year-to-date (YtD) gain decreased to **44.60%**.

What shaped today's market direction

The loss in today's market can majorly be attributed to price depreciation and profit taking in **ZENITHBANK (-0.67%)**, **GTCO (-0.59%)**, **ACCESSCORP (-0.91%)** and **PZ (-3.02%)** offsetting gains in **FIDELITYBK (4.81%)**, **WEMABANK (0.8%)**, **JAIZBANK (0.89%)** and **JAPAUFGOLD (6.7%)** which kept the ASI in a negative terrain. Losses were recorded in large-cap, mid-cap, and small-cap stocks in **NGX30**, **NGXBNK**, **NGXCG**, **NGXINDUSTR**, **NGXINS**. The market breadth measured by advancers/decliners was negative closing at **0.32x**, indicating more laggards than advancers. The top gainers include **ASOSAVINGS (10.00%)**, **DEAPCAP (9.83%)**, **CORNERST (8.70%)**, **NEIMETH (8.65%)** and **JAPAUFGOLD (6.70%)**.

Sectoral performance was negative

Sectoral performance was negative. All our observed indices closed negatively due to price depreciation and profit taken in **NGX30**, **NGXBNK**, **NGXCG**, **NGXINDUSTR**, and **NGXINS** except **NGXOILGAS** which closed flat. As a result, the year-to-date (YTD) gain decreased to **44.60%**.

At the close of today's trade **LINKASSURE (-10.00%)**, **RTBRISCOE (-10.00%)**, **NAHCO (-9.95%)**, **MBENEFIT (-9.89%)** and **AIICO (-9.89%)** were among the 40 market laggards as 130 stocks traded today.

Market activity measured by aggregate volume decreased by **30.88%**, with aggregate value depreciating by **26.10%**. Investors traded a total of **364.34mn** units of shares valued at **N11.35bn** in **32,411** deals.

The most active stocks by volume were **ACCESSCORP**, which traded **22.80mn**, followed by **ZENITHBANK** with **21.93mn** units, **CHAMS** with **17.84mn** units, **ASOSAVINGS** with **14.76mn**, and **AIICO** with **14.02mn** units.

The most active stocks by value were **DANGCEM**, which traded **N2.15bn**, followed by **ZENITHBANK** with **N1.3bn**, **WAPCO** with **N1.02bn**, **ARADEL** with **N644.00mn**, and **GTCO** with **N519.94mn**.
