

# Daily Market Report



Tuesday, November 18, 2025

## ASI mirrored the global market trend .....depreciating by 12bps for the day

The local bourse (NGX) depreciated by **12bps** driven by price depreciation and profit taking in all sectoral tickers except **NGXINS**. As a result, the benchmark All Share Index (ASI) closed negatively to settle at **144,986.51**.

Market Capitalization closed negatively at **N92.21trillion**, as investors lost **N110.20billion**, and Year-to-date (YtD) gain decreased to **40.86%**.

### What shaped today's market direction

The loss in today's market can majorly be attributed to price depreciation and profit taking in **ZENITHBANK (-3.1%)**, **ACCESSCORP (-1.12%)**, **FIDELITYBK (-0.26%)** and **UBA (-2.51%)** offsetting gains in **GTCO (0.35%)**, **UACN (8.52%)**, **STERLINGNG (0.68%)** and **FIRSTHOLDCO (0.5%)** which kept the ASI in a negative terrain. Losses were recorded in large-cap, mid-cap, and small-cap stocks in **NGX30**, **NGXBNK**, **NGXCG**, **NGXOILGAS**. The market breadth measured by advancers/ decliners was negative closing at **0.96x**, indicating more laggards than advancers. The top gainers include **NCR (9.95%)**, **UPL (9.8%)**, **TANTALIZER (9.79%)**, **CAVERTON (9.57%)** and **UNIONDICON (9.52%)**.

### Sectoral performance was negative

Sectoral performance was negative. All our observed indices closed negatively due to price depreciation and profit taken in **NGX30**, **NGXBNK**, **NGXCG**, **NGXOILGAS** except **NGXINS** which closed positively. As a result, the year-to-date (YTD) gain decreased to **40.86%**.

At the close of today's trade **LIVINGTRUST (-9.90%)**, **MCNICHOLS (-9.00%)**, **LIVESTOCK (-7.75%)**, **REGALINS (-6.56%)** and **UPDC (-6.14%)** were among the **28** market laggards as **130** stocks traded today.

Market activity measured by aggregate volume decreased by **5.38%**, with aggregate value depreciating by **71.33%**. Investors traded a total of **367.29mn** units of shares valued at **N8.92bn** in **21,673** deals.

The most active stocks by volume were **TANTALIZER**, which traded **58.77mn**, followed by **STERLINGNG** with **31.41mn** units, **UNIVINSURE** with **28.10mn** units, **VERITASKAP** with **25.24mn**, and **ACCESSCORP** with **15.46mn** units.

The most active stocks by value were **ARADEL**, which traded **N1.71bn**, followed by **ZENITHBANK** with **N743.65mn**, **GTCO** with **N671.39mn**, **MTNN** with **N655.25mn**, and **SEPLAT** with **N552.69mn**.
