ASI mirrored the global market trenddepreciating by 23bps for the day

The local bourse (NGX) declined by **23bps** driven by price depreciation and profit taking in all sectoral tickers except **NGXINDUSTR**. As a result, the benchmark All Share Index (ASI) closed negatively to settle at **144,646.01**.

Market Capitalization closed negatively at **N92trillion**, as investors lost **N216.57billion**, and Year-to-date (YtD) gain decreased to **40.53%**.

What shaped today's market direction

The loss in today's market can majorly be attributed to price depreciation and profit taking in **ACCESSCORP (-1.59%)**, **ARADEL (-0.85%)**, **ZENITHBANK (-2.46%)** and **GTCO (-1.4%)** offsetting gains in **NESTLE (2.89%)**, **TANTALIZER (7.36%)**, **UACN (8.33%)** and **STERLINGNG (1.34%)** which kept the ASI in a negative terrain. Losses were recorded in large-cap, mid-cap, and small-cap stocks in **NGX30**, **NGXBNK**, **NGXCG**, **NGXINS**, **NGXOILGAS**. The market breadth measured by advancers/decliners was negative closing at **0.41x**, indicating more laggards than advancers. The top gainers include **NCR (9.85%)**, **CAVERTON (9.71%)**, **UACN (8.33%)**, **MBENEFIT (7.69%)** and **LINKASSURE (7.57%)**.

Sectoral performance was negative

Sectoral performance was negative. All our observed indices closed negatively due to price depreciation and profit taken in **NGX30**, **NGXBNK**, **NGXCG**, **NGXINS**, **NGXOILGAS** except **NGXNSTR** which closed flat. As a result, the year-to-date (YTD) gain decreased to **40.53%**.

At the close of today's trade **UNIVINSURE (-10%)**, **ABCTRANS (-9.95%)**, **LIVINGTRUST (-9.92%)**, **CHELLARAM (-9.85%)** and **ROYALEX (-9.76%)** were among the **39** market laggards as **129** stocks traded today.

Market activity measured by aggregate volume increased by **142.98%**, with aggregate value appreciating by **163.44%**. Investors traded a total of **892.45mn** units of shares valued at **N23.52bn** in **20,050** deals.

The most active stocks by volume were **ACCESSCORP**, which traded **488.36mn**, followed by **TANTALIZER** with **70.90mn** units, **JAPAULGOLD** with **54.04mn** units, **ZENITHBANK** with **34.54mn**, and **CONHALLPLC** with **31.26mn** units.

The most active stocks by value were **ACCESSCORP**, which traded **N10.57bn**, followed by **ARADEL** with **N3.57bn**, **ZENITHBANK** with **N2.07bn**, **GTCO** with **N1.59bn**, and **NESTLE** with **N1.33bn**.
