

# Daily Market Report



Thursday, November 20, 2025

## The local bourse continued its bearish trend .....depreciating by 32bps for the day

The local bourse (NGX) decreased by **32bps** driven by price depreciation and profit taking in all sectoral tickers except **NGXINDUSTR** which closed flat. As a result, the benchmark All Share Index (ASI) closed negatively to settle at **144,187.03**.

Market Capitalization closed negatively at **N91.71trillion**, as investors lost **N291.93billion**, and Year-to-date (YtD) gain decreased to **40.09%**.

### What shaped today's market direction

The loss in today's market can majorly be attributed to price depreciation and profit taking in **GTCO (-0.71%)**, **FIDELITYBK (-0.78%)**, **ACCESSCORP (-3.00%)** and **UBA (-2.63%)** offsetting gains in **ZENITHBANK (0.59%)**, **FCMB (1.42%)**, **ELLAHLAKES (1.92%)** and **FIRSTHOLDCO (0.33%)** which kept the ASI in a negative terrain. Losses were recorded in large-cap, mid-cap, and small-cap stocks in **NGX30**, **NGXBNK**, **NGXCG**, **NGXINS**, **NGXOILGAS**. The market breadth measured by advancers/ decliners was negative closing at **0.36x**, indicating more laggards than advancers. The top gainers include **NCR (10%)**, **ROYALEX (7.57%)**, **CILEASING (6%)**, **LIVINGTRUST (3.87%)** and **RTBRISCOE (3.55%)**.

### Sectoral performance was negative

Sectoral performance was negative. All our observed indices closed negatively due to price depreciation and profit taken in **NGX30**, **NGXBNK**, **NGXCG**, **NGXINS**, **NGXOILGAS** except **NGXINDUSTR** which closed flat. As a result, the year-to-date (YTD) gain decreased to 40.09%.

At the close of today's trade **NEIMETH (-10%)**, **OMATEK (-10%)**, **TANTALIZER (-9.75%)**, **INTENEGINS (-9.62%)** and **WEMABANK (-8.63%)** were among the **38** market laggards as **130** stocks traded today.

Market activity measured by aggregate volume decreased by **60.87%**, with aggregate value depreciating by **60.49%**. Investors traded a total of **349.25mn** units of shares valued at **N9.29bn** in **18,597** deals.

The most active stocks by volume were **FIDELITYBK**, which traded **54.26mn**, followed by **FCMB** with **30.34mn** units, **TANTALIZER** with **29.72mn** units, **GTCO** with **25.65mn**, and **ACCESSCORP** with **17.93mn** units.

The most active stocks by value were **GTCO**, which traded **N2.15bn**, followed by **FIDELITYBK** with **N1.03bn**, **ZENITHBANK** with **N820mn**, **MTNN** with **N627.47mn**, and **ARADEL** with **N541.08mn**.
