

# Daily Market Report

## The local bourse continued its bullish trend.....as the ASI appreciated by 10bps

The local bourse (NGX) increased by **10bps**, driven by price appreciation and increased buying interest in all sectoral tickers. As a result, the benchmark All Share Index (ASI) closed positively to settle at **145,476.15pts**.

Market Capitalization closed positively at **N92.72trillion**, as investors gained **N97.06billion**, and Year-to-date (YtD) gain increased to **41.34%**.

### What shaped today's market direction

The gains in today's market can majorly be attributed to price appreciation and increase buying interest in **GTCO (1.15%)**, **ZENITHBANK (0.83%)**, **ETI (8.53%)** and **FIRSTHOLDCO (0.32%)** offsetting losses in **NASCON (-3.67%)**, **ACCESSCORP (-0.48%)**, **UBA (-1.14%)** and **ELLAHLAKES (-10.00%)**, which kept the ASI in a positive terrain. Gains were recorded in large-cap, mid-cap, and small-cap stocks in **NGX30**, **NGXBNK**, **NGXCG**, **NGXINDUSTR**, **NGXINS**, **NGXOILGAS**. The market breadth measured by advancers/ decliners was negative closing at **0.82x**, indicating more laggards than advancers. The top gainers include **UACN (10.00%)**, **MORISON (9.94%)**, **ETI (8.53%)**, **WAPIC (8.47%)** and **MANSARD (7.75%)**.

### Sectoral performance was positive

Sectoral performance was positive. All our observed indices closed positively due to increased buying interest in **NGX30**, **NGXBNK**, **NGXCG**, **NGXINDUSTR**, **NGXINS**, and **NGXOILGAS**. As a result, the year-to-date (YTD) gain increased to **41.34%**.

At the close of today's trade **ELLAHLAKES (-10.00%)**, **EUNISELL (-10.00%)**, **TRANSCOHOT (-9.95%)**, **OMATEK (-9.23%)** and **GUINEAINS (-8.46%)** were among the **28** market laggards as **129** stocks traded today.

Market activity measured by aggregate volume decreased by **13.52%**, with aggregate value depreciating by **16.91%**. Investors traded a total of **349.17mn** units of shares valued at **N12.80bn** in **23,225** deals.

The most active stocks by volume were **FIDELITYBK**, which traded **31.01mn**, followed by **GTCO** with **28.28mn** units, **ZENITHBANK** with **27.10mn** units, **ETI** with **21.87mn** units, and **ACCESSCORP** with **17.70mn** units.

The most active stocks by value were **GTCO**, which traded **N2.48bn**, followed by **ARADEL** with **N2.03bn**, **ZENITHBANK** with **N1.63bn**, **ETI** with **N744.25mn**, and **MTNN** with **N724.38mn**.
