## Market retraces in today's market.....as the local bourse depreciated by 33bps

The local bourse (NGX) lost **33bps** in today's market, driven by price depreciation and profit taking in all sectoral tickers except **NGXOILGAS**. As a result, the benchmark All Share Index (ASI) closed negatively to settle at **146,938.86**.

Market Capitalization closed negatively at **N93.65trillion**, as investors lost **N311.74billion**, and Year-to-date (YtD) gain decreased to **42.76%**.

### What shaped today's market direction

The loss in today's market can majorly be attributed to price depreciation and profit taking in **ACCESSCORP (-0.71%)**, **ZENITHBANK (-0.77%)**, **FCMB (-0.9%)** and **CORNERST (-0.91%)** offsetting gains in **GTCO (1.05%)**, **NAHCO (1%)**, **FIRSTHOLDCO (0.32%)** and **JAPAUFGOLD (5.5%)** which kept the ASI in a negative terrain. Losses were recorded in large-cap, mid-cap, and small-cap stocks in **NGX30**, **NGXBNK**, **NGXCG**, **NGXINDUSTR**, **NGXINS**. The market breadth measured by advancers/ decliners was negative closing at **0.65x**, indicating more laggards than advancers. The top gainers include **LEARNAFRCA (9.57%)**, **MECURE (8.72%)**, **DEAPCAP (7.5%)**, **INTENEGINS (6.52%)** and **RTBRISCOE (5.96%)**.

### Sectoral performance was negative

Sectoral performance was negative. All our observed indices closed negatively due to price depreciation and profit taken in **NGX30**, **NGXBNK**, **NGXCG**, **NGXINDUSTR**, **NGXINS** except **NGXOILGAS** which closed positively. As a result, the year-to-date (YTD) gain decreased to **42.76%**.

At the close of today's trade **AUSTINLAZ (-10%)**, **ETERNA (-10%)**, **TRANSCOHOT (-9.95%)**, **IKEJAHOTEL (-9.65%)** and **UACN (-9.09%)** were among the 32 market laggards as 128 stocks traded today.

Market activity measured by aggregate volume increased by **72.06%**, with aggregate value appreciating by **64.05%**. Investors traded a total of **947.75mn** units of shares valued at **N22.69bn** in **22,883** deals.

The most active stocks by volume were **ACCESSCORP**, which traded **183.55mn**, followed by **CORNERST** with **115.97mn** units, **CONHALLPLC** with **79.41mn** units, **FCMB** with **78.08mn**, and **JAPAUFGOLD** with **62.07mn** units.

The most active stocks by value were **STANBIC**, which traded **N4.04bn**, followed by **ACCESSCORP** with **N3.76bn**, **GTCO** with **N2.97bn**, **ARADEL** with **N1.27bn**, and **ZENITHBANK** with **N1.05bn**.
