Market dropped further today.....as the local bourse depreciated by 5bps

The local bourse (NGX) lost **5bps** in today's market, driven by price depreciation and profit taking in all sectoral tickers. As a result, the benchmark All Share Index (ASI) closed negatively to settle at **146,861.36pts**.

Market Capitalization closed negatively at **N93.6trillion**, as investors lost **N49.39billion**, and Year-to-date (YtD) gain decreased to **42.69%**.

What shaped today's market direction

The loss in today's market can majorly be attributed to price depreciation and profit taking in **FIDELITYBK (-0.26%)**, **ACCESSCORP (-2.87%)**, **CORNERST (-3.67%)** and **JAIZBANK (-1.11%)** offsetting gains in **GTCO (0.27%)**, **FCMB (0.46%)**, **CUTIX (1%)** and **UBA (0.63%)** which kept the ASI in a negative terrain. Losses were recorded in large-cap, mid-cap, and small-cap stocks in **NGX30**, **NGXBNK**, **NGXCG**, **NGXINS**, and **NGXOILGAS**. The market breadth measured by advancers/ decliners was positive closing at **1.21x**, indicating more advancers than laggards. The top gainers include **JAPAULGOLD (10%)**, **PRESTIGE (9.4%)**, **MECURE (7.72%)**, **TIP (7.3%)** and **CONHALLPLC (6.97%)**.

Sectoral performance was negative

Sectoral performance was negative. All our observed indices closed negatively due to price depreciation and profit taken in **NGX30**, **NGXBNK**, **NGXCG**, **NGXINS**, **NGXOILGAS** except **NGXINDUSTR** which closed flat. As a result, the year-to-date (YTD) gain decreased to **42.69%**.

At the close of today's trade **CHAMS (-10%)**, **HMCALL (-8.88%)**, **UACN (-8.18%)**, **SUNUASSUR (-6.98%)** and **LINKASSURE (-4.35%)** were among the **23** market laggards as **127** stocks traded today.

Market activity measured by aggregate volume decreased by **21.18%**, with aggregate value depreciating by **45.30%**. Investors traded a total of **747.06mn** units of shares valued at **N12.41bn** in **19,012** deals.

The most active stocks by volume were **CUTIX**, which traded **122.91mn**, followed by **FCMB** with **80.66mn** units, **CONHALLPLC** with **71.17mn** units, **FIDELITYBK** with **63.83mn** units, and **TANTALIZER** with **57.83mn** units.

The most active stocks by value were **GTCO**, which traded **N2.73bn**, followed by **FIDELITYBK** with **N1.21bn**, **ACCESSCORP** with **N905.07mn**, **FCMB** with **N879.25mn**, and **ZENITHBANK** with **N683.34mn**.
