Bulls regain control of the market.....as the local bourse advances by 74bps today

In today's market, the local bourse (NGX) closed the day on a bullish note as ASI appreciated by **74bps** driven by price appreciation and increased buying interest in all sectoral tickers except **NGXBNK**, and **NGXOILGAS**. As a result, the benchmark All Share Index (ASI) closed positively to settle at **147,950.59pts**.

Market Capitalization closed positively at **N94.3trillion**, as investors gained **N694.26billion**, and Year-to-date (YtD) gain increased to **43.74%**.

What shaped today's market direction

The gains in today's market can majorly be attributed to price appreciation and increase buying interest in **MTNN (4.91%)**, **NB (7.57%)**, **PZ (9.36%)** and **DANGSUGAR (5.89%)** offsetting losses in **ACCESSCORP (-0.49%)**, **ZENITHBANK (-0.08%)**, **FIRSTHOLDCO (-1.1%)** and **GTCO (-0.44%)** which kept the ASI in a positive terrain. Gains were recorded in large-cap, mid-cap, and small-cap stocks in **NGX30**, **NGXCG**, **NGXINDUSTR**, and **NGXINS**. The market breadth measured by advancers/ decliners was positive, closing at **1.29x**, indicating more advancers than laggards. The top gainers include **BERGER (9.88%)**, **JAPAUFGOLD (9.88%)**, **MORISON (9.77%)**, **PZ (9.36%)** and **LEGENDINT (8.91%)**.

Sectoral performance was positive

Sectoral performance was positive. All our observed indices closed positively due to increased buying interest in **NGX30**, **NGXCG**, **NGXINDUSTR**, and **NGXINS** except **NGXBNK**, and **NGXOILGAS** which closed negatively. As a result, the year-to-date (YTD) gain increased to **43.74%**.

At the close of today's trade **JOHNHOLT (-9.26%)**, **CHAMPION (-7.86%)**, **ETERNA (-5.48%)**, **VFDGROUP (-5.07%)** and **TIP (-4.8%)** were among the **24** market laggards as **128** stocks traded today.

Market activity measured by aggregate volume decreased by **29.10%**, with aggregate value depreciating by **0.82%**. Investors traded a total of **529.68mn** units of shares valued at **N12.31bn** in **18,017** deals.

The most active stocks by volume were **ACCESSCORP**, which traded **156.31mn** units, followed by **FCMB** with **74.54mn** units, **FIDELITYBK** with **42.93mn** units, **JAPAUFGOLD** with **41.15mn**, and **ZENITHBANK** with **20.32mn** units.

The most active stocks by value were **ACCESSCORP**, which traded **N3.16bn**, followed by **ZENITHBANK** with **N1.31bn**, **MTNN** with **N1.09bn**, **FCMB** with **N819.5mn**, and **FIDELITYBK** with **N812.7mn**.
