

# Daily Market Report



Friday, November 21, 2025

## The local bourse closed the week bearish by 219bps ..... down by 27bps today

The local bourse (NGX) closed the week on a bearish note, by **219bps** as a result of selling pressures during the week. In today's market, ASI depreciated by **27bps**, driven by price depreciation and selling pressures in all sectoral tickers. As a result, the benchmark All Share Index (ASI) closed negatively to settle at **143,790.91pts**.

Market Capitalization closed negatively at **N91.45trillion**, as investors lost **N251.95billion**, and Year-to-date (YtD) gain decreased to **39.70%**.

### What shaped today's market direction

The loss in today's market can majorly be attributed to price depreciation and profit taking in **ZENITHBANK (-0.17%)**, **ACCESSCORP (-2.38%)**, **MTNN (-1.06%)** and **UBA (-0.27%)** offsetting gains in **UACN (2.49%)**, **GTCO (0.6%)**, **FIDELITYBK (0.26%)** and **TRANSCORP (0.74%)** which kept the ASI in a negative terrain. Losses were recorded in large-cap, mid-cap, and small-cap stocks in **NGX30**, **NGXCG**, **NGXINDUSTR**, **NGXINS**, **NGXOILGAS**. The market breadth measured by advancers/ decliners was negative closing at **0.44x**, indicating more laggards than advancers. The top gainers include **NCR (9.89%)**, **IKEJAHOTEL (9.74%)**, **NEIMETH (9.09%)**, **MAYBAKER (8.60%)** and **REGALINS (6.60%)**.

### Sectoral performance was negative

Sectoral performance was negative. All our observed indices closed negatively due to price depreciation and profit taken in **NGX30**, **NGXCG**, **NGXINDUSTR**, **NGXINS**, **NGXOILGAS** except **NGXBNK** which closed positively. As a result, the year-to-date (YTD) gain decreased to **39.70%**.

At the close of today's trade **RTBRISCOE (-10.00%)**, **LEGENDINT (-9.93%)**, **INTENEGINS (-9.79%)**, **NAHCO (-9.78%)** and **LINKASSURE (-9.68%)** were among the **38** market laggards as **129** stocks traded today.

Market activity measured by aggregate volume increased by **88.07%**, with aggregate value appreciating by **175.28%**. Investors traded a total of **656.86mn** units of shares valued at **N25.58bn** in **18,695** deals.

The most active stocks by volume were **ACCESSCORP**, which traded **128.68mn**, followed by **ZENITHBANK** with **91.50mn** units, **UACN** with **74.37mn** units, **GTCO** with **48.42mn**, and **FIDELITYBK** with **37.72mn** units.

The most active stocks by value were **ZENITHBANK**, which traded **N5.45bn**, followed by **UACN** with **N5.17bn**, **GTCO** with **N4.07bn**, **ACCESSCORP** with **N2.64bn**, and **STANBIC** with **N1.61bn**.
