

# Daily Market Report



Thursday, November 27, 2025

## The All-Share Index closed on a bullish note..... up by 12bps for the day

The local bourse (NGX) closed the day on a bullish note as ASI appreciated by **12bps** driven by price appreciation and increased buying interest in all sectoral tickers except **NGXINDUSTR**, and **NGXOILGAS**. As a result, the benchmark All Share Index (ASI) closed positively to settle at **143,239.23pts**.

Market Capitalization closed positively at **N91.1trillion**, as investors gained **N111.09billion**, and Year-to-date (YtD) gain increased to **39.17%**.

### What shaped today's market direction

The gains in today's market can majorly be attributed to price appreciation and increase buying interest in **GTCO (0.12%)**, **MTNN (1.08%)**, **UBA (0.28%)** and **FIDELITYBK (0.52%)** offsetting losses in **ZENITHBANK (-0.5%)**, **TRANSPOWER (-0.26%)**, **WAPCO (-0.15%)** and **WEMABANK (-0.82%)** which kept the ASI in a positive terrain. Gains were recorded in large-cap, mid-cap, and small-cap stocks in **NGX30**, **NGXBNK**, **NGXCG**, **NGXINS**. The market breadth measured by advancers/ decliners was positive, closing at **1.65x**, indicating more advancers than laggards. The top gainers include **LINKASSURE (10.00%)**, **IKEJAHOTE (10.00%)**, **NCR (9.96%)**, **LEARNAFRCA (9.96%)** and **UNIONDICON (9.52%)**.

### Sectoral performance was positive

Sectoral performance was positive. All our observed indices closed positively due to increased buying interest in **NGX30**, **NGXBNK**, **NGXCG**, **NGXINS** except **NGXINDUSTR**, and **NGXOILGAS** which closed negatively. As a result, the year-to-date (YTD) gain increased to **39.17%**.

At the close of today's trade **CHAMPION (-9.85%)**, **STERLINGNG (-8.33%)**, **UPDC (-8.23%)**, **CILEASING (-4.83%)** and **GUINEAINS (-4.35%)** were among the **20** market laggards as **128** stocks traded today.

Market activity measured by aggregate volume decreased by **56.18%**, with aggregate value depreciating by **65.99%**. Investors traded a total of **323.52mn** units of shares valued at **N12.08bn** in **18,195** deals.

The most active stocks by volume were **FIDELITYBK**, which traded **32.19mn**, followed by **UBA** with **28.21mn** units, **GTCO** with **26.19mn** units, **ZENITHBANK** with **24.55mn**, and **ACCESSCORP** with **14.44mn** units.

The most active stocks by value were **GTCO**, which traded **N2.26bn**, followed by **MTNN** with **N1.62bn**, **ZENITHBANK** with **N1.48bn**, **UBA** with **N1.02bn**, and **FIDELITYBK** with **N615.14mn**.
