The ASI closed the day on bullish note.....appreciated by 42bps today

The local bourse (NGX) closed the day on a bullish note as ASI advanced by **42bps** driven by price appreciation and increased buying interest in all sectoral tickers except **NGXBNK**, and **NGXCG**. As a result, the benchmark All Share Index (ASI) closed positively to settle at **155,034.72pts**.

Market Capitalization closed positively at **N98.84trillion**, as investors gained **N411.34billion**, and Year-to-date (YtD) gain increased to **50.63%**.

What shaped today's market direction

The gains in today's market can majorly be attributed to price appreciation and increase buying interest in **FCMB (1.38%)**, **ZENITHBANK (0.24%)**, **WEMABANK (6.28%)** and **ACCESSCORP (1.67%)** offsetting losses in **FIRSTHOLDCO (-9.94%)**, **UBA (-0.37%)**, **CHAMS (-1.88%)** and **NB (-4.68%)** which kept the ASI in a positive terrain. Gains were recorded in large-cap, mid-cap, and small-cap stocks in **NGX30**, **NGXINDUSTR**, **NGXINS**, and **NGXOILGAS**. The market breadth measured by advancers/ decliners was positive closing at **1.91x**, indicating more advancers than laggards. The top gainers include **GUINEAINS (10.00%)**, **HONYFLOUR (10.00%)**, **JBERGER (10.00%)**, **AUSTINLAZ (9.94%)** and **MULTIVERSE (9.88%)**.

Sectoral performance was positive

Sectoral performance was positive. All our observed indices closed positively due to increase buying interest in **NGX30**, **NGXINDUSTR**, **NGXINS**, and **NGXOILGAS** except **NGXBNK**, and **NGXCG** which closed negatively. As a result, the year-to-date (YTD) gain increased to **50.63%**.

At the close of today's trade **UNIONDICON (-10.00%)**, **LIVINGTRUST (-10.00%)**, **FIRSTHOLDCO (-9.94%)**, **VERITASKAP (-7.47%)** and **MBENEFIT (-7.46%)** were among the **24** market laggards as **129** stocks traded today.

Market activity measured by aggregate volume increased by **219.02%**, with aggregate value appreciating by **10.11%**. Investors traded a total of **4.68bn** units of shares valued at **N38.86bn** in **34,708** deals.

The most active stocks by volume were **CORNERST**, which traded **3670.10mn** units, followed by **FCMB** with **302.35mn** units, **WEMABANK** with **97.39mn** units, **ACCESSCORP** with **75.07mn** units, and **CHAMS** with **47.53mn** units.

The most active stocks by value were **CORNERST**, which traded **N18.53bn**, followed by **FCMB** with **N3.32bn**, **ZENITHBANK** with **N2.26bn**, **WEMABANK** with **N1.86bn**, and **ACCESSCORP** with **N1.63bn**.
