The ASI continues its bullish trendadvanced by 46bps in today's market

In today's market, the local bourse (NGX) advanced by **46bps** driven by price appreciation and increased buying interest in **NGX30**, **NGXINDUSTR**, and **NGXINS**. As a result, the benchmark All Share Index (ASI) closed positively to settle at **159,951.08pts**.

Market Capitalization closed positively at **N102.14trillion**, as investors gained **N469.76billion**, and Year-to-date (YtD) gain increased to **2.79%**.

What shaped today's market direction

The gains in today's market can majorly be attributed to price appreciation and increase buying interest in **GTCO (3.04%)**, **DANGCEM (4.27%)**, **WAPCO (4.07%)** and **PRESCO (6.21%)** offsetting losses in **ARADEL (-4.79%)**, **ZENITHBANK (-0.15%)**, **ACCESSCORP (-6.00%)** and **UBA (-6.22%)** which kept the ASI in a positive terrain. Gains were recorded in large-cap, mid-cap, and small-cap stocks in **NGX30**, **NGXINDUSTR**, and **NGXINS**. The market breadth measured by advancers/decliners was positive, closing at **3.09x**, indicating more advancers than laggards. The top gainers include **MEYER (10.00%)**, **JAIZBANK (10.00%)**, **ABCTRANS (9.98%)**, **AUSTINLAZ (9.94%)** and **MULTIVERSE (9.94%)**.

Sectoral performance was mixed

Sectoral performance was mixed. Some of our observed indices closed positively due to increased buying interest in **NGX30**, **NGXINDUSTR**, and **NGXINS** while **NGXBNK**, **NGXCG**, and **NGXOILGAS** closed negatively. As a result, the year-to-date (YTD) gain increased to **2.79%**.

At the close of today's trade **ALEX (-9.96%)**, **LEARNAFRCA (-9.16%)**, **OANDO (-7.69%)**, **UBA (-6.22%)** and **ACCESSCORP (-6.00%)** were among the **21** market laggards as **130** stocks traded today.

Market activity measured by aggregate volume increased by **9.10%**, with aggregate value appreciating by **6.84%**. Investors traded a total of **758.92mn** units of shares valued at **N19.83bn** in **54,081** deals.

The most active stocks by volume were **LINKASSURE**, which traded **51.63mn** units, followed by **STERLINGNG** with **49.14mn** units, **ACCESSCORP** with **48.73mn** units, **MBENEFIT** with **34.67mn** units, and **REGALINS** with **26.36mn** units.

The most active stocks by value were **GTCO**, which traded **N2.03bn**, followed by **ARADEL** with **N1.54bn**, **ZENITHBANK** with **N1.34bn**, **DANGCEM** with **N1.2bn**, and **ACCESSCORP** with **N1.17bn**.
