The market closed the week on a bullish note by 238bps...closed flat by 6bps today

The NGX closed the week on a bullish note by **238bps**. In today's market, the local bourse (NGX) ended by **6bps** driven by price appreciation and increased buying interest in all sectoral tickers except **NGXINDUSTR**, and **NGXOILGAS**. As a result, the benchmark All Share Index (ASI) closed positively to settle at **166,154.55pts**.

Market Capitalization closed positively at **N106.38trillion**, as investors gained **N62.27billion**, and Year-to-date (YtD) gain increased to **6.77%**.

What shaped today's market direction

The gains in today's market can majorly be attributed to price appreciation and increase buying interest in **ZENITHBANK (1.23%)**, **GTCO (0.05%)**, **PZ (3.77%)** and **WEMABANK (0.22%)** offsetting losses in **ACCESSCORP (-0.22%)**, **JAIZBANK (-0.12%)**, **NB (-0.60%)** and **WAPCO (-1.81%)** which kept the ASI in a positive terrain. Gains were recorded in large-cap, mid-cap, and small-cap stocks in **NGX30**, **NGXBNK**, **NGXCG**, and **NGXINS**. The market breadth measured by advancers/decliners was positive closing at **1.65x**, indicating more advancers than laggards. The top gainers include **REDSTAREX (10.00%)**, **NCR (9.97%)**, **SCOA (9.96%)**, **OMATEK (9.94%)** and **DEAPCAP (9.85%)**.

Sectoral performance was positive

Sectoral performance was positive. All our observed indices closed positively due to increase buying interest in **NGX30**, **NGXBNK**, **NGXCG**, and **NGXINS** except **NGXINDUSTR**, and **NGXOILGAS** which closed negatively. As a result, the year-to-date (YTD) gain increased to **6.77%**.

At the close of today's trade **MCNICHOLS (-8.81%)**, **LEGENDINT (-7.56%)**, **CORNERST (-6.48%)**, **CILEASING (-6.29%)** and **AUSTINLAZ (-5.78%)** were among the **26** market laggards as **130** stocks traded today.

Market activity measured by aggregate volume decreased by **47.36%**, with aggregate value depreciating by **46.78%**. Investors traded a total of **539.84mn** units of shares valued at **N16.68bn** in **47,876** deals.

The most active stocks by volume were **ZENITHBANK**, which traded **54.54mn** units, followed by **JAIZBANK** with **41.48mn** units, **NSLTECH** with **37.73mn** units, **ACCESSCORP** with **30.52mn** units, and **LASACO** with **27.23mn** units.

The most active stocks by value were **ZENITHBANK**, which traded **N3.79bn**, followed by **GTCO** with **N1.53bn**, **OKOMUOIL** with **N1.53bn**, **ARADEL** with **N1.05bn**, and **MTNN** with **N726.98mn**.
