

# Daily Market Report



Monday, January 19, 2026

## The market starts the week flat .....as ASI closed by 1bps today

The NGX starts the week flat. In today's market, the local bourse (NGX) depreciated by **1bps** driven by price depreciation and profit taking in **NGX30**, **NGXCG**, and **NGXINS**. As a result, the benchmark All Share Index (ASI) closed negatively to settle at **166,112.50pts**.

Market Capitalization closed negatively at **N106.34trillion**, as investors lost **N10.88billion**, and Year-to-date (YtD) gain decreased to **6.75%**.

### What shaped today's market direction

The loss in today's market can majorly be attributed to price depreciation and profit taking in **GTCO (-1.57%)**, **FIRSTHOLDCO (-1.92%)**, **JAIZBANK (-2.32%)** and **FIDSON (-0.14%)** offsetting gains in **ZENITHBANK (2.22%)**, **ACCESSCORP (0.66%)**, **FIDELITYBK (0.25%)** and **CHAMPION (10.00%)** which kept the ASI in negative terrain. Losses were recorded in large-cap, mid-cap, and small-cap stocks in **NGX30**, **NGXCG**, and **NGXINS**. The market breadth measured by advancers/ decliners was positive closing at **1.83x**, indicating more advancers than laggards. The top gainers include **NCR (10.00%)**, **CHAMPION (10.00%)**, **LEARNAFRCA (10.00%)**, **TRIPPLEG (9.94%)** and **NEIMETH (9.90%)**.

### Sectoral performance was mixed

Sectoral performance was mixed. Some of our observed indices closed positively due to increased buying interest in **NGXBNK**, and **NGXOILGAS**, while **NGX30**, **NGXCG**, and **NGXINS** closed negatively with **NGXINDUSTR** closing flat. As a result, the year-to-date (YTD) gain decreased to **6.75%**

At the close of today's trade **IMG (-9.95%)**, **HMCALL (-9.88%)**, **LIVINGTRUST (-9.57%)**, **IKEJAHOTEL (-7.28%)** and **UNIONDICON (-5.26%)** were among the **24** market laggards as **130** stocks traded today.

Market activity measured by aggregate volume increased by **16.62%**, while aggregate value appreciating by **11.64%**. Investors traded a total of **629.57mn** units of shares valued at **N14.74bn** in **57,718** deals.

The most active stocks by volume were **NSLTECH**, which traded **83.30mn** units, followed by **ACCESSCORP** with **52.87mn** units, **JAIZBANK** with **39.73mn** units, **TANTALIZER** with **34.24mn** units, and **FIDELITYBK** with **23.69mn** units.

The most active stocks by value were **ZENITHBANK**, which traded **N1.56bn**, followed by **ARADEL** with **N1.51bn**, **ACCESSCORP** with **N1.21bn**, **GTCO** with **N1.2bn**, and **UBA** with **N697.22mn**.
