

# Daily Market Report



Tuesday, January 20, 2026

## The All Share Index closed the day slightly higher.....up by 9bps today

The local bourse (NGX) appreciated by 9bps driven by price appreciation and increased buying interest in **NGXINS**, **NGXOILGAS**. As a result, the benchmark All Share Index (ASI) closed positively to settle at **166,259.59**.

Market Capitalization closed positively at **N106.43trillion**, as investors gained **N94.16billion**, and Year-to-date (YtD) gain increased to **6.84%**.

### What shaped today's market direction

The gains in today's market can majorly be attributed to price appreciation and increase buying interest in **ZENITHBANK (0.84%)**, **ARADEL (5.68%)**, **TANTALIZER (9.81%)** and **VITAFOAM (3.89%)** offsetting losses in **GTCO (-2.46%)**, **UBA (-0.44%)**, **FIRSTHOLDCO (-1.96%)** and **TRANSCORP (-3.12%)** which kept the ASI in a positive terrain. Gains were recorded in large-cap, mid-cap, and small-cap stocks in **NGXINS**, **NGXOILGAS**. The market breadth measured by advancers/ decliners was positive closing at **1.56x**, indicating more advancers than laggards. The top gainers include **REDSTAREX (10%)**, **DEAPCAP (10%)**, **NPFMCRFBK (10%)**, **NCR (9.97%)** and **MORISON (9.97%)**.

### Sectoral performance was mixed

Sectoral performance was mixed. Some of our observed indices closed positively due to increased buying interest in **NGXINS**, **NGXOILGAS** while **NGXBNK**, **NGXCG** closed negatively. As a result, the year-to-date (YTD) gain increased to **6.84%**.

At the close of today's trade **ALEX (-9.95%)**, **JAIZBANK (-9.87%)**, **FTNCOCOA (-8.44%)**, **UPDC (-8.06%)** and **CAVERTON (-5.59%)** were among the **25** market laggards as **130** stocks traded today.

Market activity measured by aggregate volume increased by **26.35%**, with aggregate value appreciating **35.47%**. Investors traded a total of **795.45mn** units of shares valued at **N19.97bn** in **45,277** deals.

The most active stocks by volume were **TANTALIZER**, which traded **86.96mn** units, followed by **NSLTECH** with **74.15mn** units, **ZICHIS** with **69.60mn** units, **ZENITHBANK** with **49.10mn** units, and **GTCO** with **39.05mn** units.

The most active stocks by value were **GTCO**, which traded **N3.79bn**, followed by **ZENITHBANK** with **N3.53bn**, **ARADEL** with **N2.79bn**, **MTNN** with **N964.59mn**, and **ACCESSCORP** with **N692.04mn**.
