

Daily Market Report



Tuesday, February 10, 2026

The market closed the day on a bullish note.....appreciating by 164bps today.

The local bourse (NGX) closed the day on a bullish note as ASI appreciated by **164bps** driven by price appreciation and increased buying interest in all sectoral tickers. As a result, the benchmark All Share Index (ASI) closed positively to settle at **176,803.24**.

Market Capitalization closed positively at **N113.49trillion**, as investors gained N1.83trillion, and Year-to-date (YtD) gain increased to **13.62%**.

What shaped today's market direction

The gains in today's market can majorly be attributed to price appreciation and increase buying interest in **MTNN (3.71%)**, **GTCO (0.8%)**, **ZENITHBANK (2.42%)** and **ARADEL (7.14%)** offsetting losses in **OANDO (-2.13%)**, **TRANSCORP (-1.96%)**, **FIDSON (-1.51%)** and **VERITASKAP (-2.99%)** which kept the ASI in a positive terrain. Gains were recorded in large-cap, mid-cap, and small-cap stocks in **NGX30**, **NGXBNK**, **NGXCG**, **NGXINDUSTR**, **NGXINS**, **NGXOILGAS**. The market breadth measured by advancers/ decliners was positive, closing at **3.00x**, indicating more advancers than laggards. The top gainers include **OMATEK (10%)**, **DEAPCAP (10%)**, **ETRANZACT (10%)**, **JOHNHOLT (10%)** and **VITAFOAM (9.98%)**.

Sectoral performance was positive

Sectoral performance was positive. All our observed indices closed positively due to increase buying interest in **NGX30**, **NGXBNK**, **NGXCG**, **NGXINDUSTR**, **NGXINS**, **NGXOILGAS**. As a result, the year-to-date (YTD) gain increased to **13.62%**.

At the close of today's trade **ABBEYBDS (-9.82%)**, **SKYAVN (-9.06%)**, **GUINEAINS (-6.67%)**, **CONHALLPLC (-6.64%)** and **LIVESTOCK (-6.34%)** were among the 22 market laggards as **131** stocks traded today.

Market activity measured by aggregate volume increased by **35.48%**, with aggregate value appreciating by **74.77%**. Investors traded a total of **1.05bn** units of shares valued at **N48.69bn** in **58,797** deals.

The most active stocks by volume were **ACCESSCORP**, which traded **135.53mn** units, followed by **VERITASKAP** with **67.29mn** units, **TANTALIZER** with **54.73mn** units, **ZENITHBANK** with **52.08mn** units, and **GTCO** with **45.60mn** units.

The most active stocks by value were **MTNN**, which traded **N6.8bn**, followed by **GTCO** with **N4.6bn**, **ZENITHBANK** with **N3.95bn**, **ARADEL** with **N3.82bn**, and **WAPCO** with **N3.7bn**.
