The ASI falls slightly in today's market..... the local bourse was down by 9bps

The local bourse (NGX) decreased by **9bps** driven by price depreciation and profit taking in all sectoral tickers except **NGXBNK**, **NGXINDUSTR**. As a result, the benchmark All Share Index (ASI) closed negatively to settle at **195,888.79**.

Market Capitalization closed negatively at **N125.74trillion**, as investors lost **N113.82billion**, and Year-to-date (YtD) gain decreased to **25.88%**.

What shaped today's market direction

The loss in today's market can majorly be attributed to price depreciation and profit taking in **DANGCEM (-0.61%)**, **ZENITHBANK (-0.16%)**, **NB (-1.39%)** and **UBA (-0.75%)** offsetting gains in **WEMABANK (0.2%)**, **GTCO (0.85%)**, **WAPCO (1.7%)** and **NGXGROUP (10%)** which kept the ASI in a negative terrain. Losses were recorded in large-cap, mid-cap, and small-cap stocks in **NGX30**, **NGXCG**, **NGXINS**, **NGXOILGAS**. The market breadth measured by advancers/ decliners was negative closing at **0.72x**, indicating more laggards than advancers. The top gainers include **NGXGROUP (10%)**, **PREMINTS (9.92%)**, **OMATEK (8.95%)**, **PRESTIGE (8.39%)** and **HMCALL (6.67%)**.

Sectoral performance was negative

Sectoral performance was negative. All our observed indices closed negatively due to price depreciation and profit taken in **NGX30**, **NGXCG**, **NGXINS**, **NGXOILGAS** except **NGXBNK**, **NGXINDUSTR** which closed positively. As a result, the year-to-date (YTD) gain decreased to **25.88%**.

At the close of today's trade **PRESCO (-10%)**, **UACN (-9.97%)**, **MORISON (-9.94%)**, **LIVINGTRUST (-9.91%)** and **SCOA (-9.86%)** were among the **40** market laggards as **131** stocks traded today.

Market activity measured by aggregate volume decreased by **10.12%**, with aggregate value depreciating by **6.20%**. Investors traded a total of **671.25mn** units of shares valued at **N26.11bn** in **58,663** deals.

The most active stocks by volume were **WEMABANK**, which traded **106.36mn** units, followed by **ACCESSCORP** with **59.02mn** units, **MBENEFIT** with **38.49mn** units, **FTGINSURE** with **32.74mn** units, and **STERLINGNG** with **30.20mn** units.

The most active stocks by value were **WEMABANK**, which traded **N2.75bn**, followed by **ARADEL** with **N2.08bn**, **DANGCEM** with **N1.96bn**, **ZENITHBANK** with **N1.77bn**, and **MTNN** with **N1.59bn**.
