ASI Recovers to Post Gains in Today's Market..... Appreciating by 52bps

The local bourse (NGX) closed the day on a bullish note as ASI appreciated by **52bps** driven by price appreciation and increased buying interest in **NGX30**, and **NGXINDUSTR**. As a result, the benchmark All Share Index (ASI) closed positively to settle at **196,910.40pts**.

Market Capitalization closed positively at **N126.39trillion**, as investors gained **N649.52billion**, and Year-to-date (YtD) gain increased to **26.54%**.

What shaped today's market direction

The gains in today's market can majorly be attributed to price appreciation and increase buying interest in **ZENITHBANK (0.16%)**, **MTNN (0.63%)**, **WAPCO (0.29%)** and **NGXGROUP (0.83%)** offsetting losses in **GTCO (-0.47%)**, **CUSTODIAN (-2.53%)**, **ACCESSCORP (-0.40%)** and **UBA (-0.43%)** which kept the ASI in a positive terrain. Gains were recorded in large-cap, mid-cap, and small-cap stocks in **NGX30**, and **NGXINDUSTR**. The market breadth measured by advancers/decliners was negative closing at **1.00x**, indicating more laggards than advancers. The top gainers include **FTNCOCOA (10.00%)**, **FIDSON (9.97%)**, **DEAPCAP (9.89%)**, **CAVERTON (9.40%)** and **LIVESTOCK (9.30%)**.

Sectoral performance was negative

Sectoral performance was negative. All our observed indices closed negatively due to price depreciation and profit taken in **NGXBNK**, **NGXCG**, **NGXINS**, **NGXOILGAS** except **NGX30**, **NGXINDUSTR** which closed positively. As a result, the year-to-date (YTD) gain increased to **26.54%**.

At the close of today's trade **OMATEK (-10.00%)**, **ETERNA (-10.00%)**, **SCOA (-9.94%)**, **FTGINSURE (-9.24%)** and **SOVRENINS (-9.09%)** were among the 30 market laggards as **132** stocks traded today.

Market activity measured by aggregate volume decreased by **18.10%**, while aggregate value depreciating by **71.23%**. Investors traded a total of **549.73mn** units of shares valued at **N44.72bn** in **55,316** deals.

The most active stocks by volume were **FTGINSURE**, which traded **32.18mn** units, followed by **ACCESSCORP** with **28.12mn** units, **FIRSTHOLDCO** with **27.72mn** units, **ZENITHBANK** with **27.48mn** units, and **DANGCEM** with **26.89mn** units.

The most active stocks by value were **DANGCEM**, which traded **N20.67bn**, followed by **ARADEL** with **N4.11bn**, **ZENITHBANK** with **N2.55bn**, **GTCO** with **N1.59bn**, and **PRESCO** with **N1.53bn**.
