

# Daily Market Report

## Market holds steady above 200,000 pts... appreciating by 11bps to close at 200,925

In today's market, the local bourse (NGX) appreciated by **11bps** driven by price appreciation and increased buying interest in **NGX30, NGXINS**. As a result, the benchmark All Share Index (ASI) closed positively to settle at **200,925.75**.

Market Capitalization closed positively at **N128.97trillion**, as investors gained **N141.13billion**, and Year-to-date (YtD) gain increased to **29.12%**.

### What shaped today's market direction

The gains in today's market can majorly be attributed to price appreciation and increase buying interest in **MTNN (2.41%), GTCO (3.2%), WEMABANK (0.38%)** and **ACCESSCORP (0.19%)** offsetting losses in **ZENITHBANK (-5.32%), WAPCO (-0.78%), UBA (-1.46%)** and **NGXGROUP (-0.88%)** which kept the ASI in a positive terrain. Gains were recorded in large-cap, mid-cap, and small-cap stocks in **NGX30, NGXINS**. The market breadth measured by advancers/ decliners was flat closing at **1.00x**, indicating more laggards than advancers. The top gainers include **LEGENDINT (10%), ZICHIS (9.93%), PREMPAINTS (9.93%), JOHNHOLT (9.79%)** and **CONHALLPLC (6.26%)**.

### Sectoral performance was mixed

Sectoral performance was mixed. Some of our observed indices closed positively due to increase buying interest in **NGX30, NGXINS** while **NGXBNK, NGXCG, NGXINDUSTR** closed negatively. As a result, the year-to-date (YTD) gain increased to **29.12%**.

At the close of today's trade **FIDSON (-9.97%), AUSTINLAZ (-9.89%), LIVINGTRUST (-7.08%), NSLTECH (-7.04%)** and **STERLINGNG (-5.56%)** were among the **32** market laggards as **133** stocks traded today.

Market activity measured by aggregate volume decreased by **52.08%**, with aggregate value depreciating by **58.99%**. Investors traded a total of **515.33mn** units of shares valued at **N25.13bn** in **45,356** deals.

The most active stocks by volume were **WEMABANK**, which traded **104.33mn** units, followed by **ACCESSCORP** with **42.76mn** units, **ZENITHBANK** with **33.85mn** units, **GTCO** with **25.57mn** units, and **FIDELITYBK** with **21.18mn** units.

The most active stocks by value were **MTNN**, which traded **N4.23bn**, followed by **ZENITHBANK** with **N3.56bn**, **GTCO** with **N2.86bn**, **WEMABANK** with **N2.75bn**, and **WAPCO** with **N1.28bn**.
