Market holds steady above 200,000 pts... closing flat by 2bps to close at 200,957.89

In today's market, the local bourse (NGX) closed the day on a bullish note as ASI advanced by **2bps** driven by price appreciation and increased buying interest in **NGX30, NGXBNK, NGXCG**. As a result, the benchmark All Share Index (ASI) closed positively to settle at **200,957.89**.

Market Capitalization closed positively at **N128.99trillion**, as investors gained **N20.63billion**, and Year-to-date (YtD) gain increased to **29.14%**.

What shaped today's market direction

The gains in today's market can majorly be attributed to price appreciation and increase buying interest in **MTNN (0.15%), ZENITHBANK (1.53%), GTCO (0.74%)** and **FIRSTHOLDCO (0.1%)** offsetting losses in **ACCESSCORP (-0.19%), WEMABANK (-0.19%), WAPCO (-1.54%)** and **NGXGROUP (-6.46%)** which kept the ASI in a positive terrain. Gains were recorded in large-cap, mid-cap, and small-cap stocks in **NGX30, NGXBNK, NGXCG**. The market breadth measured by advancers/decliners was negative closing at **0.83x**, indicating more laggards than advancers. The top gainers include **PREMPAIRS (10%), ZICHIS (10%), LEGENDINT (9.92%), JOHNHOLT (9.87%)** and **MCNICHOLS (9.76%)**.

Sectoral performance was mixed

Sectoral performance was mixed. Some of our observed indices closed positively due to increase buying interest in **NGX30, NGXBNK, NGXCG** while **NGXINDUSTR, NGXINS, NGXOILGAS** closed negatively. As a result, the year-to-date (YTD) gain increased to **29.14%**.

At the close of today's trade **UPL (-9.17%), SUNUASSUR (-8.88%), VERITASKAP (-6.98%), FTNCOCOA (-6.67%)** and **NGXGROUP (-6.46%)** were among the 36 market laggards as **132** stocks traded today.

Market activity measured by aggregate volume increased by **31.42%**, with aggregate value appreciating by **31.46%**. Investors traded a total of **677.28mn** units of shares valued at **N33.04bn** in **41,812** deals.

The most active stocks by volume were **ACCESSCORP**, which traded **134.59mn** units, followed by **WEMABANK** with **105.51mn** units, **VERITASKAP** with **74.14mn** units, **ZICHIS** with **22.95mn** units, and **UBA** with **18.12mn** units.

The most active stocks by value were **MTNN**, which traded **N11.06bn**, followed by **ACCESSCORP** with **N3.49bn**, **WEMABANK** with **N2.79bn**, **ARADEL** with **N1.99bn**, and **ZENITHBANK** with **N1.76bn**.
