The Market Closes the Week Higher, Up 104bps W-O-W.....Up by 55bps Today

The market ends to close the week on a bullish note by **104bps**. In today's market, the local bourse (NGX) closed the day on a bullish note as ASI increased by **55bps** driven by price appreciation and increased buying interest in all sectoral tickers except **NGXINS**, and **NGXOILGAS**. As a result, the benchmark All Share Index (ASI) closed positively to settle at **203,791.18pts**.

Market Capitalization closed positively at **N131.49trillion**, as investors gained **N721.78billion**, and Year-to-date (YtD) gain increased to **30.96%**.

What shaped today's market direction

The gains in today's market can majorly be attributed to price appreciation and increase buying interest in **GTCO (2.66%)**, **WAPCO (8.52%)**, **UBA (0.43%)** and **NGXGROUP (1.62%)** offsetting losses in **JAIZBANK (-2.02%)**, **FCMB (-3.33%)**, **TRANSCORP (-7.1%)** and **TIP (-2.63%)** which kept the ASI in a positive terrain. Gains were recorded in large-cap, mid-cap, and small-cap stocks in **NGX30**, **NGXBNK**, **NGXCG**, and **NGXINDUSTR**. The market breadth measured by advancers/ decliners was negative closing at **0.71x**, indicating more laggards than advancers. The top gainers include **TRANSEXPR (9.91%)**, **INTBREW (9.88%)**, **CHAMS (9.84%)**, **GUINNESS (9.38%)** and **WAPCO (8.52%)**.

Sectoral performance was positive

Sectoral performance was positive. All our observed indices closed positively due to increased buying interest in **NGX30**, **NGXBNK**, **NGXCG**, and **NGXINDUSTR** except **NGXINS**, and **NGXOILGAS** which closed negatively. As a result, the year-to-date (YTD) gain increased to **30.96%**.

At the close of today's trade **OMATEK (-10.00%)**, **AUSTINLAZ (-9.93%)**, **WAPIC (-9.88%)**, **ZICHIS (-9.58%)** and **CORNERST (-8.77%)** were among the **32** market laggards as **133** stocks traded today.

Market activity measured by aggregate volume decreased by **15.99%**, with aggregate value depreciating by **21.15%**. Investors traded a total of **548.41mn** units of shares valued at **N31.36bn** in **48,161** deals.

The most active stocks by volume were **ACCESSCORP**, which traded **52.70mn** units, followed by **ZENITHBANK** with **47.79mn** units, **UBA** with **38.88mn** units, **NSLTECH** with **36.69mn** units, and **GTCO** with **34.90mn** units.

The most active stocks by value were **ARADEL**, which traded **N6.49bn**, followed by **ZENITHBANK** with **N5.34bn**, **GTCO** with **N4.63bn**, **MTNN** with **N2.20bn**, and **WAPCO** with **N2.10bn**.
