The Nigerian All Share Index Maintains the Bullish Trajectory.....up by 71bps today

The local bourse (NGX) closed the day on a bullish note as ASI advanced by **71bps** driven by price appreciation and increased buying interest in all sectoral tickers. As a result, the benchmark All Share Index (ASI) closed positively to settle at **205,913.93**.

Market Capitalization closed positively at **N132.54trillion**, as investors gained **N936.61billion**, and Year-to-date (YtD) gain increased to **32.32%**.

What shaped today's market direction

The gains in today's market can majorly be attributed to price appreciation and increase buying interest in **ZENITHBANK (2.13%)**, **GTCO (3.07%)**, **WAPCO (5.06%)** and **SEPLAT (9.42%)** offsetting losses in **MTNN (-2.15%)**, **VFDGROUP (-0.88%)**, **OANDO (-1.1%)** and **PZ (-4.25%)** which kept the ASI in a positive terrain. Gains were recorded in large-cap, mid-cap, and small-cap stocks in **NGX30**, **NGXBNK**, **NGXCG**, **NGXINDUSTR**, **NGXINS**, **NGXOILGAS**. The market breadth measured by advancers/ decliners was positive closing at 2.05x, indicating more advancers than laggards. The top gainers include **ETI (10%)**, **STANBIC (10%)**, **NGXGROUP (9.97%)**, **CORNERST (9.94%)** and **MECURE (9.92%)**.

Sectoral performance was positive

Sectoral performance was positive. All our observed indices closed positively due to increase buying interest in **NGX30**, **NGXBNK**, **NGXCG**, **NGXINDUSTR**, **NGXINS**, **NGXOILGAS**. As a result, the year-to-date (YTD) gain increased to **32.32%**.

At the close of today's trade **FTGINSURE (-8.2%)**, **MCNICHOLS (-8.17%)**, **ACADEMY (-6.96%)**, **INTENEGINS (-6.88%)** and **GUINEAINS (-5.83%)** were among the **20** market laggards as **132** stocks traded today.

Market activity measured by aggregate volume increased by **21.14%**, while aggregate value appreciating by **0.67%**. Investors traded a total of **569.19mn** units of shares valued at **N32.17bn** in **45,545** deals.

The most active stocks by volume were **ACCESSCORP**, which traded **67.52mn** units, followed by **ZENITHBANK** with **39.74mn** units, **VFDGROUP** with **37.60mn** units, **GTCO** with **30.56mn** units, and **LASACO** with **26.30mn** units.

The most active stocks by value were **ARADEL**, which traded **N5.48bn**, followed by **ZENITHBANK** with **N4.5bn**, **GTCO** with **N3.79bn**, **WAPCO** with **N3.24bn**, and **SEPLAT** with **N2.28bn**.
