

Daily Market Report



Tuesday, April 28, 2026

The All Share Index Rebounds.....appreciating by 224bps for the day.

The local bourse (NGX) increased by **224bps** driven by price appreciation and increased buying interest in **NGX30**, **NGXINDUSTR**, and **NGXOILGAS**. As a result, the benchmark All Share Index (ASI) closed positively to settle at **228,602.00pts**.

Market Capitalization closed positively at **N147.18trillion**, as investors gained **N3.21trillion**, and Year-to-date (YtD) gain increased to **46.90%**.

What shaped today's market direction

The gains in today's market can majorly be attributed to price appreciation and increase buying interest in **ARADEL (9.52%)**, **ZENITHBANK (0.7%)**, **MTNN (0.09%)** and **WAPCO (10%)** offsetting losses in **NESTLE (-4.61%)**, **ACCESSCORP (-7.98%)**, **UBA (-10%)** and **FIDELITYBK (-3.48%)** which kept the ASI in a positive terrain. Gains were recorded in large-cap, mid-cap, and small-cap stocks in **NGX30**, **NGXINDUSTR**, and **NGXOILGAS**. The market breadth measured by advancers/decliners was negative closing at **0.97x**, indicating more laggards than advancers. The top gainers include **FTNCOCOA (10.00%)**, **IMG (10.00%)**, **WAPCO (10.00%)**, **AUSTINLAZ (9.71%)** and **PRESCO (9.52%)**.

Sectoral performance was mixed

Sectoral performance was mixed. Some of our observed indices closed positively due to increased buying interest in **NGX30**, **NGXINDUSTR**, and **NGXOILGAS** while **NGXBNK**, **NGXCG**, and **NGXINS** closed negatively. As a result, the year-to-date (YTD) gain increased to **46.90%**.

At the close of today's trade **UBA (-10.00%)**, **TRANSEXPR (-9.99%)**, **NASCON (-9.18%)**, **JAIZBANK (-8.98%)** and **BERGER (-8.66%)** were among the 40 market laggards as 132 stocks traded today.

Market activity measured by aggregate volume increased by **41.51%**, with aggregate value appreciating by **59.87%**. Investors traded a total of **959.44mn** units of shares valued at **N70.41bn** in **74,445** deals.

The most active stocks by volume were **ACCESSCORP**, which traded **243.40mn** units, followed by **FIDELITYBK** with **66.76mn** units, **WEMABANK** with **54.83mn** units, **LINKASSURE** with **47.63mn** units, and **ZENITHBANK** with **41.63mn** units.

The most active stocks by value were **NESTLE**, which traded **N15.26bn**, followed by **ARADEL** with **N8.66bn**, **ACCESSCORP** with **N6.41bn**, **ZENITHBANK** with **N5.08bn**, and **MTNN** with **N5.04bn**.
